


SECTION 7, TOWNSHIP 25 SOUTH, RANGE 32 EAST, N.M.P.M.

DIRECTIONS TO LOCATION

FROM THE INTERSECTION OF STATE HIGHWAY 128 & CR 1 (ORLA HIGHWAY) GO SOUTH ON CR 1 APPROX. 8.2 MILES TO MONSANTO ROAD ON RIGHT (WEST). TURN WEST ON MONSANTO ROAD GO APPROX. 2.1 MILES ROAD TURNS RIGHT (NORTH). GO NORTH APPROX. 0.9 MILE ROAD TURNS LEFT (WEST). GO WEST APPROX. 25'. TURN RIGHT (NORTH) GO NORTH APPROX. 954' TO A PROPOSED ROAD LATH ON LEFT (WEST). FOLLOW PROPOSED ROAD LATHS WEST APPROX. 887', THEN NORTHWEST 132', THEN 30' NORTH (TOTAL OF 1049') TO THE SOUTHEAST PAD CORNER FOR THIS LOCATION.







TURN WEST ON MONSANTO ROAD GO APPROX. 2.1 MILES ROAD TURNS RIGHT (NORTH). GO NORTH APPROX. 0.9 MILE ROAD TURNS LEFT (WEST). GO WEST APPROX. 25'. TURN RIGHT (NORTH) GO NORTH APPROX. 954' TO A PROPOSED ROAD LATH ON LEFT (WEST). FOLLOW PROPOSED ROAD LATHS WEST APPROX. 887', THEN NORTHWEST 132', THEN 30' NORTH (TOTAL OF 1049') TO THE SOUTHEAST PAD CORNER FOR THIS LOCATION.


