Apache has found a suspected casing leak. We would like a verbal to rig up on this well, locate the leak, and isolate the producing interval with a retrievable bridge plug pending approval from partners to squeeze the leak.

If the leak is found to be located in the free pipe interval below the DV tool, Apache will punch holes in the casing as necessary to establish circulation through the bottom and out the top of this free pipe interval in order to perform remedial cement work.
