5/4/2017 Repaired road and cleared location. Installed 3 temporary anchors. Rigged up and installed BOP. Unset packer and tallied tubing out of the hole. Set 4 ½" CIBP at 2750'. Caught circulation and tested casing. Casing good to 500#. Circulated MLF and spotted 45 sx cement on top of CIBP and POOH.

5/8/2017 Perforated casing at 1000'. Set packer at 695'. Pressured up to 500#. Could not establish rate. POOH with packer and RIH open ended to 1074' and spotted 25 sx Class C cement with CaCl. WOC and tagged cement at 821'. Perforated at 180'. Established circulation and pumped cement down 4 ½" casing to perfs at 180' and up annulus to surface. Took 60 sx. Rigged down.

5/9/2017 Cut off wellhead. Cement was to surface on both strings. Installed marker and cut off anchors. Cleaned pit and cleared location.
