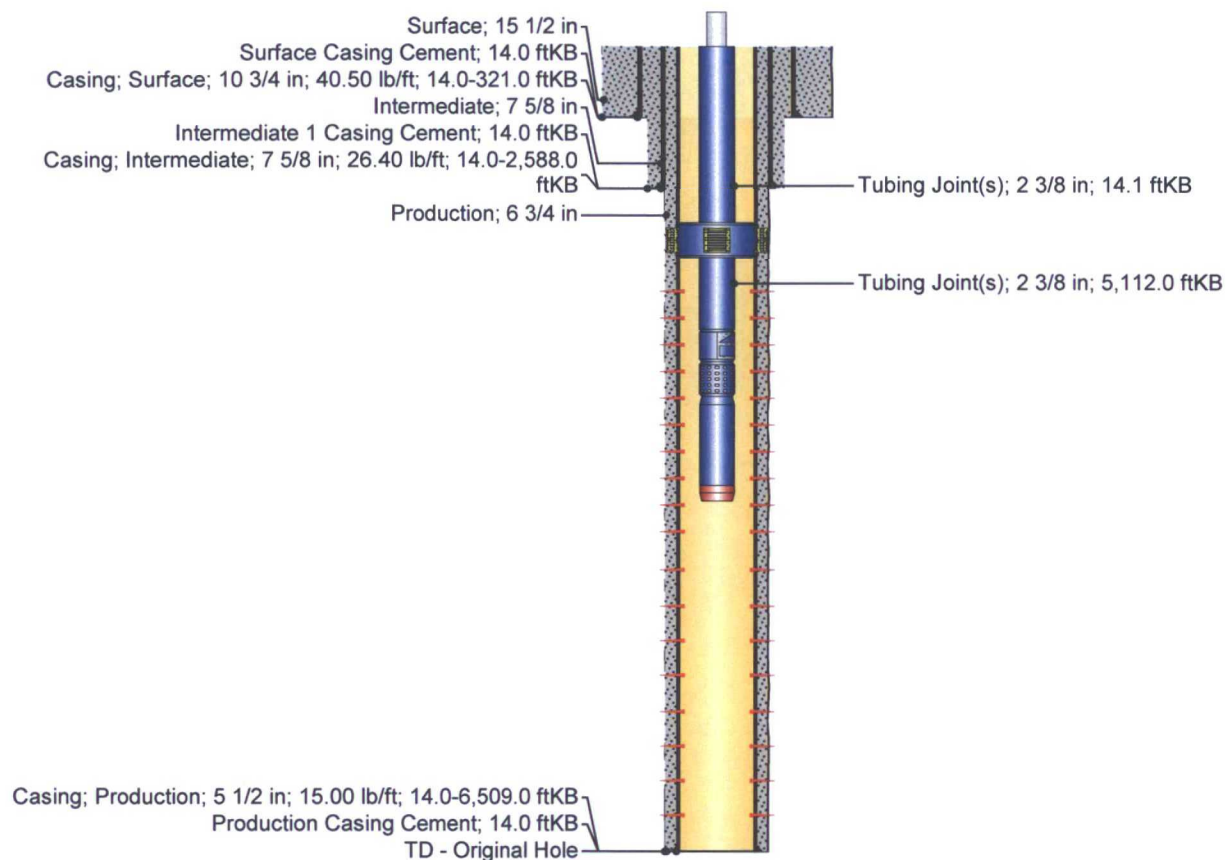


# Vertical Wellbore Diagram - RRC

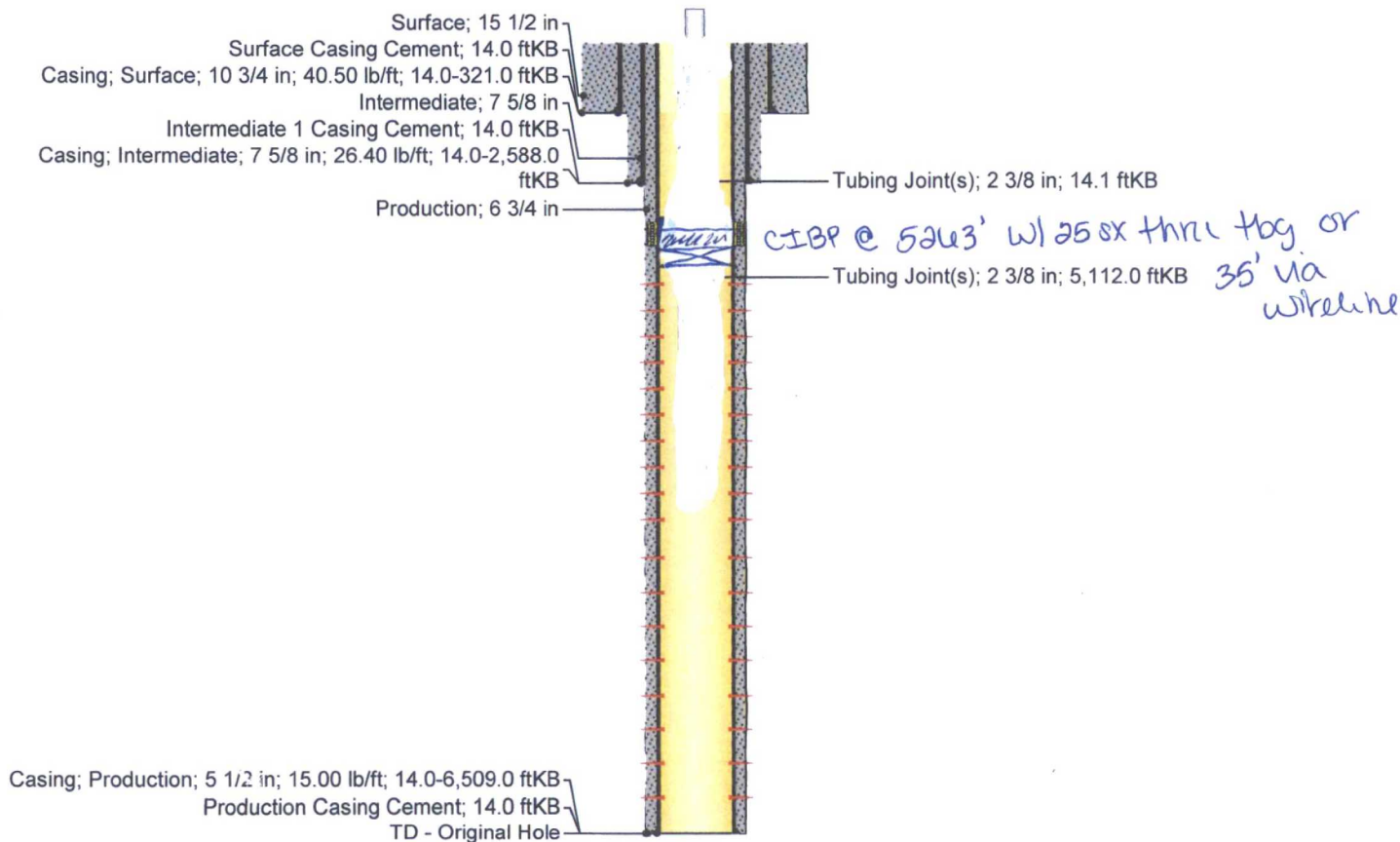
