The well pad expansion is necessary to accommodate the drilling and completion of 2 additional horizontal 2nd Bone Spring oil wells (EK 30 BS2 Federal Com 2H & the EK 31 BS2 Federal Com 1H) on this pad.

The extra space is necessary for the mobilization of the drilling and completion equipment, and the installation of the additional surface production equipment necessary to support production operations for a 3 well pad.

An Archaeological Survey will also be performed on the proposed extension area and a report will be submitted to the BLM when completed. I have attached the revised survey of the well pad with the
