PENDING THE COMPLETION OF AN ENGINEERING AND GEOLOGICAL REVIEW TO ASSESS THE FEASIBILITY AND OPTIONS OF CONTINUED BENEFICIAL USE FOR THIS WELL. AN ADDITIONAL SUNDRY 3160-5 NOTICE OF INTENT WILL THEN BE SUBMITTED ADVISING BLM OF THE PREFERRED OPTION FORWARD.
