Beginning in the fall of 2016, a pumpjack, pipe, power pole, and meter were removed from the location. On March 30, 2017, the well location was ripped using a bulldozer and the surface was seeded on April 3, 2017. Access to location has been blocked to protect the surface during reclamation.
