Beginning in the fall of 2016, a pumpjack, base, and signs were removed from the location. On March 29, 2017, the remaining caliche pad material was scraped from the location and spread onto Monsanto Lane. The well location and access road were ripped using a bulldozer and the surface was seeded on April 3, 2017. Access to the road and location has been blocked to protect the surface during reclamation.
