02/27/17 TIH with work string to 2000' and circulate 70 bbls brine. Lay down work string. ND BOP. Speared 5 1/2" casing, would not move up. Chemical cut casing at 526'. Speared casing and casing will not pick up. NU BOP.

02/28/17 Mechanical cut casing at 20'. Pull 20' casing out of well head. Pick up overshot and catch casing at 20'. Used string shot to back off collar at 578'. Lay down 17 joints of 5 1/2" casing.

03/01/17 Pick up work string and packer. Test casing below 649', will not hold. Isolate casing leak at 1064'. Lay down work string and packer.

03/02/17 Pick up 550' of 5 1/2" casing screw into casing fish. Used string shot to back off collar at 1179'. Lay down 5 1/2" casing. RIH with work string and packer, tested for leaks, held. Lay down work string and packer.

03/03/17 Pick up and ran new 5 1/2", J-55, 15.5#/ft, 8rd STC, 1180'. Tagged old casing and screwed into. Pressure test casing and held 570#. ND BOPD. Install new well head and cut off and slips and cut dressed off 5 1/2" casing. RD. Ready for MIT.

03/10/17 Perform MIT.

Note: no change of cement tops or wellbore design.
