7/11/17 - Decision was made to P&A well. Guinn Burks & Jacob Bower met with Maxie Brown & Mark Whitaker at the OCD office to propose to drill down beside 4 1/2' and perf into casing form outside and pump cmt into lower wellbore.

7/11-17 - 8-7/17 - Continued to drill down outside of casing to a depth of 1100'.

8/8/17 - RIH w/WL & perf'd 20 shots into 4 1/2" csg @ 1100', csg went on vac. Spotted 35 sx cmt, started getting CIRC to surf.

8/9/17 - 2 3/8" tbg cemented in the hole. Tagged cmt @ 1097' inside tbg. Re-perfed tbg & casing in attempt to perf into 4 1/2" csg. Pressured up. Some cmt inside csg @ 1100'. Called Guinn Burks & Mark & Maxie, discussed and agreed to agreed to P&A from free point of tbg. Free point tbg @ 740'-stuck, free @ 700'.

8/10/17 - RIH w/ dump bailer & covered perfs with cmt. Cut tbg @ 700' & spotted 20 sx Class "C" cmt @ 699', POOH w/ tbg. POOH & LD 7" csg @ 517'. RIH w/tbg & tagged @ 460' & spotted 800 sx Class "C" cmt @ 460', no CIRC to surf.

8/11/2017 - RIH & tagged cmt @ 274', wait on cementer till Monday.

8/14/17 - MIRU cementer & spotted 76 sx Class "C" cmt from 274' to surf, POOH w/ tbg & topped off surf csg. Well Plugged. RDMO.
