A well sign has been ordered and will be installed on the well ASAP.

We hereby request that the TA status of this well be extended due to recent activities in the area and the potential use of this well to be kicked off horizontally or used as an SWD. A one well cash bond is in place for this well in addition to Primero's statewide casing bond. The well has passed MITs and It is assumed that it will pass now.

We will call to set up a new MIT test sometime in October 2017.
