3. PUH & spot 25 sx Class "C" cmt from 1650' - 1400', WOC/TAG (Top of Salt)

2. PUH & spot 25 sx Class "C" cmt from 3000' - 2750', WOC/TAG (Base of Salt)

1. MIRU P&A rig. RIH w/ tbg & verify CIBP @ 3665' & CIRC w/ MLF. *Pressure test csg.*


