1. MIRU plugging rig. N/D Wellhead, N/U BOP
2. TOOH with rod and pump
3. TOOH with tubing
4. TIH with CIBP. 3565'
5. Set CIBP @ 3,615' to isolate productive interval (Yates) (Possible perf @ 3500')?
6. Spot 25 sks of cement on top of CIBP, 3,475'-3,615'. WOC and TAG
7. Load hole with 9.5 ppg plug mud
8. Pressure test csg
9. Perforate 5.5" Production Casing @ 1750'
10. Sqz 35 sks of Cement, 1650'-1750'. WOC and TAG
11. Perforate 5.5" Production Csg @ 306' (Shoe @ 256')
12. Circulate cement to surface. Est. 35 sks
13. Cut off csg, weld on 1/2" steel plate verify amt to surface
14. Erect dead well marker (See attached WBD)
