03/27/17-04/06/17 Jarred on fish. Recovered 5-1/2 jts tbg (cork screwed and bent). Tag fish @ 10,945'. Wash over fish to 10,954'. Using two more shoes was able to wash down 2 additional feet to 10,956'. Abandoned workover due to cost and lack of progress and to access plan going forward.
