10/09/17 RIH w/openended tbg to 1780'. Circulate well with 10# brine @ 1 BMP @ 1600 psi until circulated clean. Continue to trip in and circulate every 1000' until reached TD @ 5020'. BLM approved pumping a balanced plug @ 5020'. WOC and tag. Circulated 90 bbls 10# brine and 50 bbls 10# salt gel mud and then pumped 35 sx @ 5020'-4502' as per BLM allowing to cover the problem area @ 4755'-4788'. POH 25 stands and WOC overnight.
10/10/17 RIH tbg. Tag TOC @ 4493'. Update the BLM. Tested csg to 600 psi. Held. Lay down tbg. Spot 25 sx balanced plug @ 2307'-1937'. POH. RIH pkr. Set pkr @ 700'. Perforate csg @ 1100'. Squeeze 50 sx cement @ 2 BPM @ 1500 psi. WOC overnight.
10/11/17 Tag plug @ 810'. Move pkr up hole to 32'. Load hole and set pkr. Perf csg @ 100'. Squeeze/circulate 50 sx cement from 100' to surface. NDBOP. Top off 4 1/2" csg with cement. RDWSU.
