5. Acidize perms 4076-4192 w/2500 gal of 15% NEFE acid. Flush acid w/25 bbl 10# brine water.
6. RIH w/3-1/2" NP Hydraulic Isolation pkr, IPC sub, seal assembly on 123 jts of Duoline tbg. Set packer @3800'
7. Circ well w/packer fluid. Test casing to 500 PSI for 30 minutes & chart for the NMOCD.
8. RDPU/RU. Clean location.
