Ran New 13-3/8" 54.5#/ft J-55 grade STC connection Surface Casing w/ 18 centralizers to 1926' GL. Land casing, circulate & cement with Haliburton with 1050 sxs 13.7 ppg Lead cement and 730 sxs 14.8 ppg Tail cement. Good returns, good circulation. Circulated 74 bbls. of cement to surface.
