This Gas Capture Plan outlines actions to be taken by the Operator to reduce well/production facility flaring/venting for new completion (new drill, recomple to new zone, re-frac) activity.

**Gathering System and Pipeline Notification**

Well(s) will be connected to a production facility after flowback operations are complete, if gas transporter system is in place. The gas produced from production facility is dedicated to Delaware Basin Midstream, LLC (DBM) and will be connected to DBM's low/high pressure gathering system located in Lea County, New Mexico. It will require 500' of pipeline to connect the facility to low/high pressure gathering system. Chevron U.S.A. provides (periodically) to DBM a drilling, completion and estimated first production date for wells that are scheduled to be drilled in the foreseeable future. In addition, Chevron U.S.A. and DBM have periodic conference calls to discuss changes to drilling and completion schedules. Gas from these wells will be processed at DBM's Ramsey Processing Plant located in Sec. 36, Block 57-T1, Reeves County, Texas. The actual flow of the gas will be based on compression operating parameters and gathering system pressures.

**Flowback Strategy**

After the fracture treatment/completion operations, well(s) will be produced to permanent production facilities. Temporary sand separation equipment will be installed at the well and will be blown down to an atmospheric tank as needed during the initial flow period. Gas sales should start as soon as the wells start flowing through the production facilities, unless there are operational issues on the DBM system at that time. Based on current information, it is CHEVRON'S belief the system can take this gas upon completion of the well(s).

Safety requirements during cleanout operations from the use of underbalanced air cleanout systems may necessitate that sand and non-pipeline quality gas be vented and/or flared rather than sold on a temporary basis.
