Dear Cress Green:

Rule 19.15.26.12.C.(1) NMAC states...Whenever there is a continuous one-year period of non-injection into all wells in an injection or storage project or into a salt water disposal well or special purpose well, the division shall consider the project or well abandoned, and the authority for injection shall automatically terminate ipso facto.

By reporting "0" injection for the past 26 months is an indicates that the well has been idle. At 14 months ago the well had lost authority to inject. On three separate occasions, January 24, 2018, February 6, 2018 and February 7, 2018 District I Compliance Officers found the well open and the transfer pump running. At those times you were instructed to stop injection and shut in the well. Subsequently, on February 16, 2018 a District I Compliance Officer again found the well open and transfer pump running.

Despite attempts by Oil Conservation Division ("OCD") to alert you to the fact the well has lost authority, you are hereby notified that, **effective immediately, the OCD has revoked your authorization to inject into A H MEYERS A #5, 30-025-09603.** To gain authority, you must submit form C-108 to Santa Fe, verify that your company has filed all C-115 reports and is currently in compliance with 19.15.5.9 NMAC. Operators who are more than one year out of compliance, or are not compliant with 19.15.5.9 NMAC, will require additional review.
