Ling Federal No. 4, 5, and 6 will require pool commingling and sales of gas. These 3 wells will also be measured at the Ling Federal No. 3. Ling Federal No. 3 will require pool commingling with the other wells. See attached information, facility diagrams, and map.

Application for Pool Gas Commingling

Proposal for Ling Federal No. 3, 4, 5, and 6:

Fasken Oil and Ranch, Ltd. is requesting approval for the Ling Federal No. 3, 4, 5, and 6 to be pool commingled at the Ling Federal central tank battery, gas production only, located on the No. 3 well location.

The attached map shows the wells in Section 31. Also attached is the site facility diagram of the tank battery on the No. 3, and the BLM Case Recordation of all wells. Please note the federal royalty is 12.5% on all of the wells.

Gas Metering:

The Ling Federal No. 3 has a tank battery that all wells will utilize, which is located on the NWNE half of section 31. Gas production will be allocated on a daily basis based on the individual dry flow meter readings on each well. The Ling Federal No. 4 is downhole commingled (approval on 5/25/10). Its gas will be metered on its location (sales meter # is not known at this time), and then be commingled with the other wells prior to going to DCP's EFM on the #3 location. The No. 3, 5, and 6 will be metered on the No. 3 location by Fasken dry flow meters prior to being commingled. The No. 3 oil meter number is S/N 73513, water meter S/N 73515. No. 5 oil meter S/N 73512, water meter S/N 73514. No. 6 oil meter S/N 73510, water meter S/N 73511. The meters will be calibrated on a regular basis per API, NMOCD, and BLM specifications. The BLM and SLO will be notified of any future changes in the facilities.
