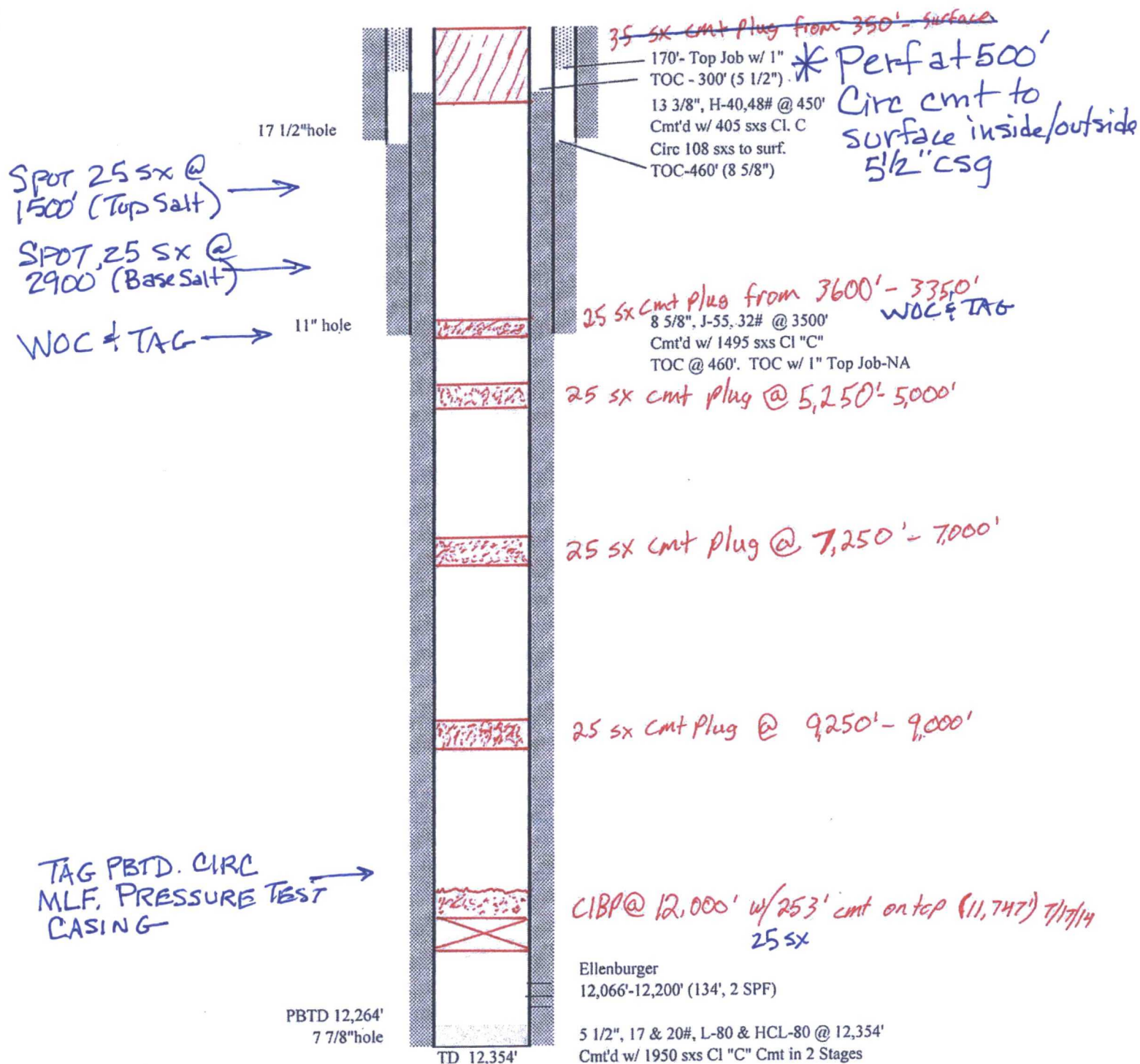

WELLBORE SCHEMATIC

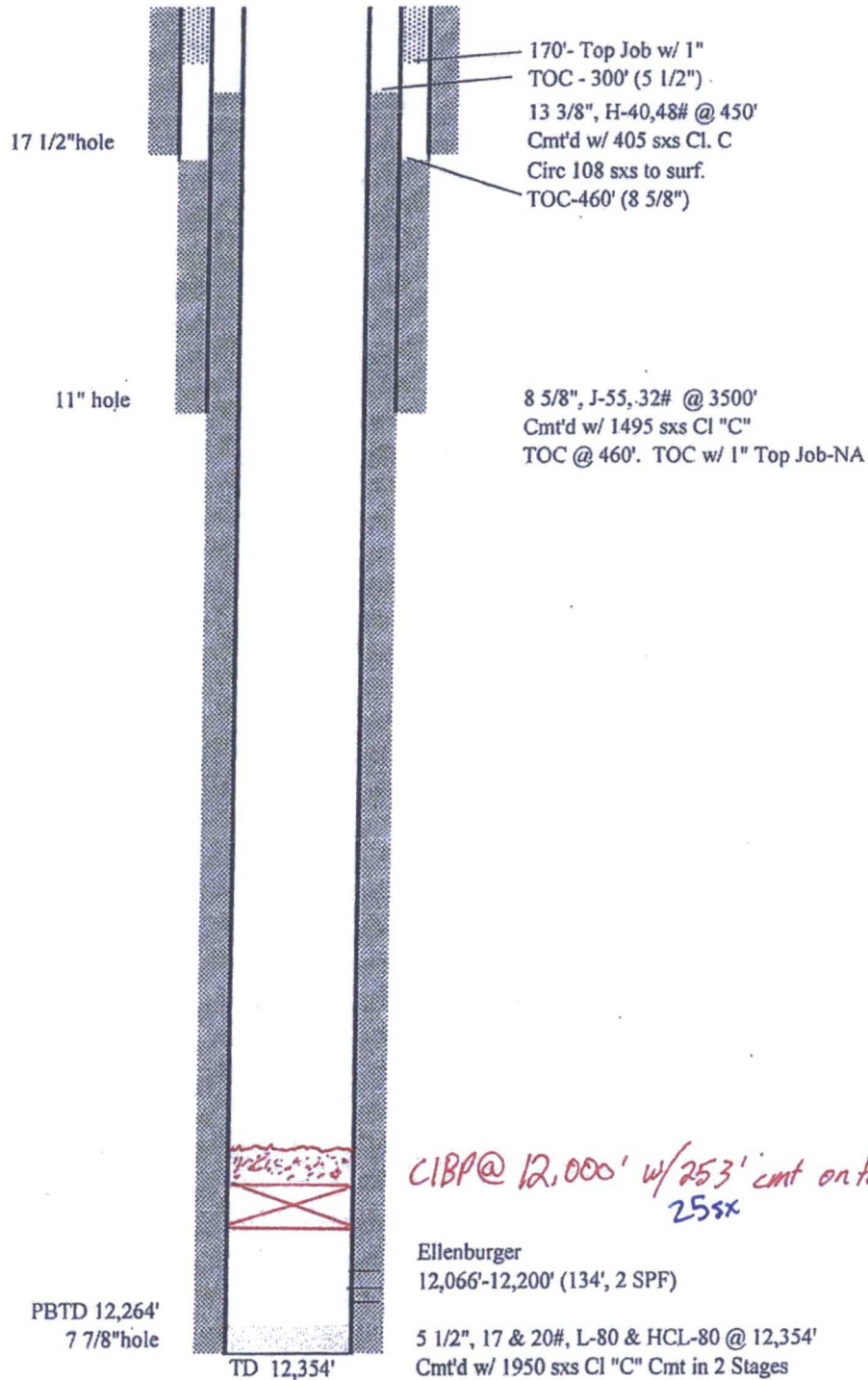
