Pilot hole plugging cement will increase from 380 sacks (372 cu. ft.) to 570 sacks (558 cu. ft.).
Production lead cement will change from 900 sx (2259 cu. ft.) to 945 sx (2371 cu.ft.).
Production tail cement will change from 1140 sx (1425 cu. ft.) to 1200 sx (1500 cu. ft.).
