ConocoPhillips Company requests access to drill soil test bore holes on the Zia Hills Federal Com Buck CF1 Facility located on BLM lands.

The intent is to drill 16 soil test bore holes on the site where the Zia Hills Federal Com Buck CF1 Facility will be built. The bore holes will be 6" in diameter and approximately 30' in depth. The bore holes will be drilled with a truck mounted drill rig. The bore holes will be filled back up after taking the samples with cement and Bentonite grout. A one call will also be requested before the drilling of the soil bore holes takes place.

The Zia Hills 19 Federal Com Buck CF1 Facility will be a central gathering and processing facility for products that come from the Zia Hills 19 Federal Com Wells (16) and the Zia Hills 20 Federal Com Wells (16). The Buck CF1 Facility is 500' x 1000' in size and contains 11.48 acres. The
