13. Describe Proposed or Completed Operation: Clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. If the proposal is to deepen directionally or recomplete horizontally, give subsurface locations and measured and true vertical depths of all pertinent markers and zones. If the operation results in a multiple completion or recompletion in a new interval, a Form 3160-4 must be filed once testing has been completed. EOG Resources requests an amendment to the following approved APDs adding the option to contract a Surface Rig to drill, set surface casing & 1st Intermediate salt string casing, and cement both strings on the subject wells. After WOC 8 hours or 500 psi compressive strength (whichever is greater), the Surface Rig will move off so the wellhead can be installed. A welder will cut the casing to the proper height and weld on the wellhead (both ?A? and ?B? sections). The weld will be tested to 1000 psi. All valves will be closed and a wellhead cap will be installed. If the timing between rigs is such that EOG Resources would not be able to preset the surface and/or intermediate salt string, the Primary Rig will MIRU and drill the well in its entirety per the APD.
