2/07/2018

Remove horse head. Ld dwn polish rod. Could not take out rods as they had too much paraffin. Closed valve. SDFN.

02/08/2018

Hot oil truck arrived. Could not pump water through tbg or casing. Put BOP on. Put backup tool on. Loosen pump, TOH with rods and pump. Had trouble taking out rods as they had paraffin. Changed over to tbg. TOH w/tbg. Tallied tbg. Closed BOP. SDFN.

2/09/2018

Open BOP. TIH W/22 stands, waited for hot oil truck to arrive. Put hot water dwn tbg. 6 tubes were plugged w/paraffin. Laid dwn 6 tubes to clean. Picked up 6 tubes. TIH w/tbg. TIH w/ remaining stands. Closed BOP and put valve. SDFN.

2/12/2018

Opened BOP. Remove BOP flange dwn. Waited on hot oiler, pumped 20 bbls of water dwn tbg. TIH W/rods and pump. Laid dwn pump. Put valve on. Closed valve. SDFN.

2/13/2018

Hot oiler pumped 30 bbls of hot oil dwn tbg. Pumped 10 bbls of water in tbg. TIH W/new pump. TIH W/rods. Put horse head on. Respaced well. Tested tbg. Did not test good. Closed valve. SDFN

2/14/2018

Unseated pump. TOH W/rods and pump. Waited for hot oiler. Put BOP. Dropped standing valve. Tested tbg. Did not test. TOH W/tbg and laid dwn 1 joint. Had a hole. TOH w/remaining tbg. Checked SN. SN was good. TIH W/SN and standing valve. Went in testing tbg. Tested good. Fished standing valve, closed BOP and put valve. SDFN

2/16/18

Opened BOP. TOH W/tbg. TIH W/notched collar. TIH tbt tallied. Closed BOP. Put valve and SDFB

2/19/18

Opened BOP. Picked up 1 joint. Circulated 120 bbls of hot water. TOH W/tbg. Took off notched collar. TIH W/tbg. Removed BOP, waited for 1 jt. Flanged dwn. Put valve and SDFN.

2/20/2018

TIH W/pump and rods. Long stroked well. Tested @ 500PSI. Tested good. Put horse head on and respaced well. RD, cleaned location.
