4/19/2018 Move in equipment and rig up. Unseated pump and laid down 75 3/4" rods. Dug out cellar and plumped to the pit.

4/23/2018 Install BOP and POOH with 63 joints 2 3/8" tubing. Could not get gauge ring past 1628'. Made bit run to 1905'. Set CIBP at 1880'. Circulated MLF and spotted 25 sx cement at 1880' on CIBP. Perforated 4 1/2" casing at 1300'. Set packer at 967'. Took 5 bbls to pressure up to 600#. Perfs are taking fluid and charging up. Bled down and repeated process with same result. POOH with packer. RIH with tubing to 1360' and spotted 25 sx cement. POOH with tubing. Set packer with 1 stand and pressured up on perfs to 300#. Closed in and SION.

4/24/2018 Tagged cement at 1108'. Approximately 12 sx cement went into the perfs behind the 4 1/2" casing. POOH and perforated at 468'. Established circulation and circulated cement tot surface with 150 sx cement. Rigged down and cut off wellhead. Filled up both strings with 15 sx cement. Installed marker and cut off anchors.
