Plugging Report

4/26/2018 Cleared location. Moved in and rigged up. Tubing was parted 3" below the slips. Installed BOP. Moved in remaining equipment and SION. Will bring fishing tools in the morning.

4/27/2018 RIH with wireline and tagged fish at 114'. Picked up overshot and could not get into the casing below th BOP. Picked up scrapper with 3 7/8" bit and cleaned up casing down to the fish. RIH with overshot and caught the tubing. Worked packer free and laid down 57 joints of 2 3/8" PVC lined tubing. Packer was originally at 1858', but was fished from 1972'. Set CIBP at 1886'. Circulated MLF and tested casing to 550#. Casing was good. Spotted 50 sx cement on CIBP and POOH. Perforated casing at 400'. Closed blinds and pressured up to 500# and held. RIH with tubing to 451' and spotted cement to surface. Used 35 sx. SION.

4/30/2018 Rigged down and cut off wellhead. Filled up both strings of casing with 35 sx cement. Installed marker and cut off anchors. Cleaned pit and cleared the location.
