THE BLM HAS BEEN NOTIFIED, JIM AMOS, WAS NOTIFIED ABOUT THE OIL STAIN ON 03/14/2018 AND GIVEN VERBAL GO AHEAD TO DO PRELIMINARY WORK NECESSARY TO GET A RIG OUT ON WELL. AN ADDITIONAL SUNDRY WILL BE SUBMITTED ONCE THE WELL HAS BEEN PLUGGED.
