Devon Energy respectfully request to change the casing as follows:

The sundry/change to the Boundary Raider 6-7 213H is for changing the 9-5/8" casing setting depth from 6,000' back to a more standard 4,450' (base of the salt). The 6,000' setting depth is based on the concern of potential water flows from 5,700'-5,900', however, based on recent offsets we don't feel the water flow potential is as high of a risk now and should be manageable.

We would like to drill the 213H setting the 9-5/8" at 4,450'. If we don't experience water flows we will set 9-5/8" at 4,450' depth on the 212H also; if we experience water flows on the 213H we will switch back to setting 9-5/8" deeper at 6,000' to cover up the water flow zone on the 212H.
