Action precipitated by "Force Majeure" caused by a wildfire on April 12, 2018, which destroyed both the electric power line servicing this well and other wells in the Allison Field operated by Rockcliff Operating New Mexico LLC and also all of the salt water poly flowline infrastructure connecting this Well (and other wells) to salt water disposal facilities. The fire is identified by fire number 206 on the New Mexico Fire Information website.

Rockcliff has contacted both Leaco and RCEC to discuss restoring electric power and Rockcliff is developing a plan to replace the poly flowlines so that it can continue to produce the subject Well. Rockcliff will file a supplemental Sundry Notice once the well has been returned to production.
