Apache only dumped 2 sxs cement by dump bailer. 2 sxs in 5.5" 17 LB casing the cement fill is only 20 feet. NMOCD rules requires 35 feet of cement on top of a CIBP to be "Zone Plugged and Abandoned". I will conditionally approve changing this to "Zone Permanently Plugged", if Apache agrees to add cement on top of the Abo plug prior to any plug backs or plug and abandonment of the well.
