RIH w/ 6 jts 7" 29# L-80 and 379 jts 7" 29# HCP-110 casing. Casing equipped with Reamer shoe at 14,780', Float collar at 14,701', Lower Hydraulic DV @ 10,212', External Casing packer @ 5,209' and Upper DV tool @ 5206'. Cement well in 3 stages:

Stage 1: Lead 550 sx NeoCem, 11.5 ppg, 2.367 cuft/sx, Tail 20 bbls SBM CMT Well Lock, 12 ppg, plug bumped 21:55, 5/14/18
 Stage 2: Lead 635 sx NeoCem 16.4 ppg, 1.08, 2.367 cuft/sx, Tail 100 sx Halcem 16.4 ppg, 1.08 cuft/sx, bump plug 21:55 5/14/18
 Stage 3: Lead 345 sx NeoCem 11.5 ppg, 2.549 cuft/sx, Tail 100 sx Halcem 14.8 ppg, 1.335 cuft/sx, bump plug 3:15 5/14/18
 Circulated cement to surface after opening DV on 2nd stage and circulated 139 sx cement to surface on 3rds stage.

WOC and NUBOP. Drill out float collar and test casing to 1000 psi 30 min OK. Drill out shoe and commence drilling 6" hole @ 11:30 pm 5/18/18.


