 - Trip a bit and cleanout well to PBTD
 - Drill out well to ±4431' (New TD)
 - Log well from TD to ±3400'
 - Selectively perforate San Andres per logs
 - Design stimulation based on new pay. Stim with 15% HCL at ±50 gal/ft
 - Plugback OH pay to match offset injector
 - Set RBP at ±3900' and ±1000' and prepare well for wellhead change
- Following wellhead change:
- MIRU PU; Pull plugs
 - RIH with ESP
 - ND BOP. NU Wellhead. RDMO PU. RTP Well

During this procedure we plan to use the closed-loop system with a steel tank and haul contents to the required disposal per ODC Rule 19.15.17
