Endurance Resources LLC respectfully requests to perform the following remedial cement job on the subject well for the 7 5/8" intermediate casing:

- 1) Run CBL (estimated 6-8 hours) ? Determine where bottom of cement is and calculate cement volume based on 10 percent excess and discuss with BLM on plans forward
- 2) TIH with packer on DP to 30 feet below the DVT and set the packer
- 3) Test the backside to 1500 psi to ensure the DVT is closed and not leaking
- 4) Unseat packer and TIH to 30 feet above float collar
- 5) Displace OBM out of hole with 9.4 ppg cut brine
- 6) Set packer and establish injection rate to verify we are pumping through float equipment ? test the backside to 1500 psi for 30 minutes
- 7) TOOH
- 8) Run in hole with perforating guns ? shoot holes at 10 feet above float collar at 11519 feet?
