5/20/18 Drill 9-7/8" hole to 11110'. 5/27/18 RIH & set 7-5/8" 26.4# L-80 csg @ 11092'. DVT @ 6434' ACP @ 6431', pump 80bbl spacer then cement w/ 669sxs (309bbl) class H w/ additives 10.18ppg, 2.59 yield followed by 167sxs (48bbl) class H w/ additives 13.2ppg, 1.61 yield. Inflate ACP to 1700#, open DVT, circ thru DVT, circ out 10bbl spacer, no cement to surface. Notify Paul Flowers at BLM, received approval to pump 2nd stage. Pump 2nd stage w/ 50bbl spacer then cement w/ 1788sxs (533bbl) class H w/ additives 13.6ppg, 1.67 yield, drop cancellation plug, pressure up & close DVT, circ 973sxs (290bbl) to surface. WOC. Install pack-off, test to 10000#, good test.
