of gas to be flared is 9,000 MCF; Value \$93 per day.

- E. This exception is requested for the following reasons: RG Exploration is testing a new well  
that is recovering frac load water. The Targa gas system is currently at capacity and cannot  
handle additional gas volume commitments. The next closest system is greater than 10 miles  
away and is also full. Targa expects to have more capacity come Fall 2018 in order to take on  
more gas volume commitments.
