Devon Energy respectfully requests the following procedure to plug and abandon set conductor:

- Pump cement job to completely fill conductor with cement
- Cut off casing 55" below GL
- Weld plate to cutoff casing. Plate needs to include the following information:
 - Company name, Well Name and Number, API Number, & Legal Description
 - Take GPS measurement of plate location
 - Can be taken with a hand-help GPS (does not need to be certified or done by a surveying company)
 - Take picture of GPS coordinate and plate
 - Send to engineer to be stored in well file for this well
 - GPS coordinate information / picture will be given to regulatory to file with C-103 (plug and abandon report)
 - Upon completion of drilling / completion, regulatory will file C-103, NMOCD will inspect location, bond on well will be released
 - Fill cellar with caliche
 - Get post job cement report from cement vendor
