

1. MIRU. POOH w/ production equipment.
2. Set CIBP at 3150'. Circulate hole with mud laden fluid. Pressure test casing to 500 psi. Spot 25 sx cement on CIBP.
3. Perf at 1950'. Squeeze w/ 45 sx cement. WOC & tag at 1800' or better.
4. Perf @ 785'. Circulate cement to surface inside/outside 4 1/2" casing.
5. Cut off wellhead 3' below ground level and verify cement to surface all strings.
6. Install below ground P&A marker. Photos should be taken prior to and after welding on plate. Record GPS reading. BLM should be notified prior to cut off so it can be witnessed.

NOTES: Mud laden fluid consists of brine water with 25 sx salt gel per 100 bbls of fluid. If casing will not hold pressure, contact the OCD for instructions prior to proceeding with P&A.


