ND BOP. Sqz'd 45 sx class C cmt # 150' - Surface. Rigged down and moved off. 08/06/18 Moved in backhoe and welder. Dug out cellar. Cut off well head. Welded on "Above Ground Dry Hole Marker". Backfilled cellar. Cut off deadmen. Cleaned location, moved off.
