

1. MIRU plugging equipment. POOH w/ production equipment.
2. Run in hole with tubing to 1350'. Circulate MLF.
3. Spot 50 sx cement. WOC & Tag.
4. POOH to 900'. Spot 30 sx cmt. WOC & Tag.
5. POOH to 100'. Pump sufficient cement to circulate to surface.
6. Cut off wellhead 3 feet below ground level.
7. Verify cement to surface on all strings.
8. Install upright P&A marker and cut off anchors.

NOTES: Mud laden fluid consists of 9.5 ppg with 25 sx salt gel per 100 bbls of fluid. If casing will not hold pressure, contact the OCD for instructions prior to proceeding with P&A.


