ConocoPhillips would like to utilize half of the existing frac pond pad to place a office trailer. ConocoPhillips would also like to install a septic system adjacent to the trailer on the west side of the pad and a fence around the trailer.

Septic system will be comprised of a Norwesco 3000 gallon above ground vertical storage tank and a Little Giant 9SN Series 4/10hp Sewage Pump. The tank will be surrounded by secondary containment with 150% capacity Tank will be inspected by TanMar Companies of Midland Texas on a weekly basis and pumped as needed. The contents of the tank will be disposed of at a permitted disposal facility.




