FIELD NOTES DESCRIBING

The centerline of a 30 foot wide proposed gas pipeline easement, being 0.07 acres of land. Said easement being located in Section 36, Township 19 South, Range 32 East, New Mexico Principal Meridian, Lea County, New Mexico.

Being more particularly described as lying 15 feet on each side of the following described centerline (see Detail "A" on sheet 2 of 2):

BEGINNING at a point from which a 3 inch iron pipe with GLO cap found for the Northeast corner of said Section 36, bears N 34°00'34" E a distance of 4,308.80 feet.

(NW/4 OF THE SE/4)

THENCE continue crossing said Section 36 the following course and distance:

S 89°58'56" W a distance of 100.53 feet to the *POINT OF TERMINATION* from which a 3 inch iron pipe with GLO cap found for the Northwest corner of said Section 36, bears N 37°49'55" W a distance of 4,508.78 feet.

The total length of the herein described proposed gas pipeline easement crossing said Section 36, being 100.53 feet (6.09 rods), containing 0.07 acres of land.


