10/5/2018 Cleared location and installed 1 anchor. Rigged up. Repaired wellhead and installed BOP. Move in remaining equipment.

10/8/2018 Made another repair on the wellhead. POOH with 44 joints tubing and tallied. Moved in workstring trailer. RIH with 45 jts to 1414' and spotted 50 sx cement with CaCl. WOC 4 hrs and tagged at 1529'. Attempted to catch circulation with 35 bbls brine followed by 45 bbls MLF. No fluid to surface. Stood back 12 stands and laid down remaining pipe. SION

10/9/2018 Dumped 2 yards gravel and tagged at 629'. Dumped ½ yard and tagged at 614'. Dumped 1 yard and tagged 591'. Dumped 2 yards and tagged at 590'. Dumped 2 yards and tagged at 517. Attempted circulation. Good blow to pit until 25 bbls and lost blow. Spotted 50 sx with CaCl at 517'. WOC and tagged at 546'. Lost 29' of fill. Called OCD. Dumped another yard of gravel and tagged at 514'. Spotted 50 sx with CaCl without attempting to circulated. Good blow to the pit while pumping cement. POOH and SION.

~~10/10/2018~~ Tagged at 512'. Dumped 1 yard of gravel. Tagged at 454'. Spotted 50 sx cement with CaCl at 454'. WOC and tagged at 270'. Established circulation and circulated cement to surface inside 8 5/8" casing with 75 sx cement. Rigged down .

10/11/2018 Dig out wellhead and cut off. Filled up casing with 5 sx cement. Installed marker, cut off anchors, cleaned pit and cleared location.
