





30' EASEMENT DESCRIPTION:

BEING an easement thirty (30) feet in width lying fifteen (15) feet on the right side and fifteen (15) feet on the left side of the survey centerline described below, being out of the southwest quarter (SW ¼) of Section 8, Township 25 South, Range 33 East, N.M.P.M., Lea County, New Mexico, and being out of a parcel of land owned by the Bureau of Land Management. Said centerline of easement being more particularly described as follows:

Commencing from a 2" iron pipe w/BC found for the southwest corner of Section 8, T25S-R33E, N.M.P.M., Lea County, New Mexico;

Thence N 76°06'16" E a distance of 2694.40' to the **Point of Beginning** of this easement having coordinates of Northing=415301.66, Easting=770061.04 feet and continuing the following courses;

Thence N 00°00'00" W a distance of 15.45' to an angle point;




