EOG Y Resources, Inc. plans to perforate and acidize as follows:

- MIRU all safety equipment as needed.
- POOH w/ rods and pump.
- Re-perforate Wolfcamp 7594 ft - 7616 ft (47) with 90 degree phasing w/.42 inch holes and deep penetrating charges.
- Acidize with 2500g 20 percent HCL as slow at 0.25 to 0.50 bpm.
- If formation continues to take acid, pump remaining 2500g (Do not pressure up on formation).
- Flush with 2 times capacity of tubing with 2 percent KCL.
- After pump is landed fill tubing with fresh water with biocide and oxygen scavenger and test stroke the pump to 500 psi two times for 5 minutes each time. Space out the pump.
- Turn well over to production.
