

5 1/2" 14# csg set at 2194' with 215 sx cement

Perforations: 1866'-1948'

1. MIRU and POOH with production equipment.
2. Make gauge ring run and set CIBP at 1766'. Circulate MLF and test casing to 500#.
3. Spot 50 sx cement on top of CIBP.
4. Perforate casing at 533'. Pump sufficient cement to circulate cement to surface inside and outside of 5 1/2" casing.
5. Cut off wellhead 3' below ground level.
6. Verify cement is to surface on all strings of casing.
7. Install upright marker and cut off anchors.
