

8 5/8" csg set at 415' with 50 sx cement
4 1/2" csg set at 2018' with 400 sx cement.
Perforations: 1873'-2000'

1. MIRU and POOH with production equipment.
2. Make gauge ring run and set 4 1/2" CIBP at 1773'. Circulate MLF and test casing to 500#.
3. Spot 35 sx cement on top of CIBP.
4. Perforate casing at 465'. Pump sufficient cement to circulate cement to surface inside and outside of 4 1/2" casing.
5. Cut off wellhead 3' below ground level.
6. Verify cement is to surface on all strings of casing.
7. Install upright marker and cut off anchors.
