

1. MIRU and POOH with production equipment. ^{1765'}
2. Make gauge ring run and set 5 1/2" CIBP at ~~1755'~~
3. Circulate MLF and test casing to 500#.
4. Spot 50 sx cmt on top of CIBP
5. Perforate 5 1/2" casing at 540' and pump sufficient cement to circulate cement inside and outside of 5 1/2" casing.
6. Cut off wellhead 3' below ground level and verify cement is to surface on all strings.
7. Install upright marker and cut off anchors.
