
8 5/8" csg set at 550' with 100 sx cement

4 1/2" 9.5# csg set at 2139' with 300 sx cement *TOL 1320'*

Perforations: 1895'-2079'

1. MIRU and POOH with production equipment.
2. Make gauge ring run and set CIBP at 1795'. Circulate MLF and test casing to 500#.
3. Spot 35 sx cement on top of CIBP.
4. Perforate casing at 600'. Pump sufficient cement to circulate cement to surface inside and outside of 4 1/2" casing.
5. Cut off wellhead 3' below ground level.
6. Verify cement is to surface on all strings of casing.
7. Install upright marker and cut off anchors.
