
8 5/8" 24 # casing set at 362'. Cemented with 325 sx cement. Cement circulated.

5 1/2" 14# casing set at 2208'. Cemented with 400 sx cement. Cement circulated.

Perforations: 1818'-2013'

1. MIRU and POOH with production equipment.
2. Make gauge ring run and set 5 1/2" CIBP at 1718'. Circulate MLF and test casing to 500#.
3. Spot 50 sx cement on top of CIBP.
4. Spot cement from 412' to surface.
5. Cut off wellhead 3' below ground level.
6. Install upright marker and cut off anchors.
